CONSIGNMENT CONTRACT

Classic Collections specializes in and welcomes *current* Luxury and Designer clothing, handbags, accessories, and select fine and fashion jewelry.

1. Merchandise should be either NEW or "LIKE NEW" and currently in style. All items must be dry-cleaned or pressed, smoke-free and on hangers. At our discretion, we may have garments dry-cleaned at Consignor's expense. We do not accept items that need repair.
2. All consignments are accepted ***By Appointment Only***. ***If shipping items to us, you must call or e-mail first so that we can determine if we can accept your merchandise.*** Due to limited space, we accept a limited number of items per appointment/shipment and on a "seasonal" basis. Management reserves the right to decline any merchandise for any reason at any time.
3. The consigned price of an item will be set by Management to reflect current market price and demand. Couture and specialty pieces may be subject to minimum price agreed to jointly by Consignor and Management.
4. The Consignment Contract is for 90 days and this period begins when the merchandise is listed online. After 30 days, merchandise ***may*** be marked down 20%. (Markdowns depend on the condition, season and demand for the item and are solely determined by Management). ***After 95 days, any unclaimed or unsold items become the property of Classic Collections.*** If you wish to reclaim your merchandise, you ***must pick up or instruct us in writing to ship to you (at your expense) within 5 business days from your contract expiration date.*** Due to limited space, all unclaimed items will be disposed of at Management's discretion.
5. Commission payments to Consignors are 50% of the actual NET Sales Price of each item less any charges for dry cleaning, or handling fees. Handling fees will be \$5 for each item.
6. Consignment Commission Periods close at the end of each month. Consignor Payments are made by the 10th of each month for sales made in the **previous month**. Payments will be mailed to Consignors with an accounting of sold inventory.
7. Reclaiming items during the 90 day Consignment period is allowed. If items are reclaimed before contract expiration, a 10% per item (of the initial price) charge will be made to Consignor for merchandise processing.
8. Consigned merchandise may be sold on our Website (www.classiccollectionsfpalmbeach.com) by clicking www.1stdibs.com and going to either Fashion or Fine Jewelry without any limitations or conditions.
9. **Classic Collections** is not liable or responsible for any type of casualty or loss due to theft, customer damage, fire or any other cause or circumstance beyond our control. Classic Collections will not warrant or guarantee authenticity of any consigned item. Online we do NOT refund, accept returns, or exchanges with the exception of Fashion items listed on 1stdibs.com where there is a 24 hour return policy. All 1stdibs Fine Jewelry sales are FINAL.
